Respective responsibilities of the body and the auditor

The body is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The body prepares an annual return in accordance with proper practices which:

- summarises the accounting records for the year ended 31 March 2015; and
- confirms and provides assurance on those matters that are important to our audit responsibilities.

Our responsibility is to review the annual return in accordance with guidance issued by the Audit Commission (see note below). Our work does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and does not provide the same level of assurance that such an audit would do.

External auditor report (ACEX0151)

Except for the matters reported below, on the basis of our review of the annual return, in our opinion the information in the annual return is in accordance with proper practices and no matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

- Section 1, Box 2, the annual precept, does not agree to the figure notified to us by the precepting authority. The figures in Boxes 2 and 3 should read £2,428 and £704 respectively. All grants, including Council Tax Support Grant, should be shown in Box 3, as per the guidance notes on the Annual Return. In addition, the Council has not restated the prior year figures in Boxes 2 and 3, as reported in our prior year External Auditor Report, these figures should read £3,535 and £86 respectively. Please ensure the correct figures are entered for 2014/15 when completing the 2015/16 Annual Return.
- The Body failed to approve the Annual Return by 30 June 2015, the date required by the Accounts and Audit (England) Regulations 2011.

Other matters not affecting our opinion which we draw to the attention of the Council:

- All figures in Section 1 should be rounded to the nearest £1, in accordance with the guidance contained within the Annual Return.
- The Body name has been omitted from Section 4.
- Section 1 of the current year should be restated to reflect the removal of the War Memorial Fund balances and transaction. As a result of this Section 1 Boxes 1 and 6 should read £574 and £765 respectively. Please ensure the correct figures are entered for 2014/15 when completing the 2015/16 Annual Return.
