54/5. Highways

- Traffic Calming
 - 30mph sign – Bentley Road
Cllr Buxton stated that he had previously written to Bernard Jenkins and they were now in correspondence regarding the situation.
Cllr Guglielmi – recently held a surgery which incorporated the speed limit on Bentley Road. The opinion is that if the speed limit was lowered, drivers would not take any notice. Previous monitoring showed that there was an average within the limit. Cllr Guglielmi had previously suggested a footway be installed from War memorial to the pub. Stated he would push this

forward on behalf on the LBPC if they wished. Sending over minutes of the meeting. Unanimously agreed that Cllr Guglielmi should take forward.

54/6. Reinstating Ancient Footpaths around the village

Received archived Foot Path map from parishioner which clerk distributed to Councillors. Council do not have an opinion on this, and stated that it should be published in the messenger to see if any residents have any objections, then make comment once they know peoples views. Cllr Buxton proposed, Cllr Smith 2nd Unanimously agreed that Cllr Spall publish it in the messenger and await any response.

Email form trainee TDC Building & Maintenance Surveyor – Victoria Found, outlining costs involved with supplying electricity to the unit. Council agreed that there was not enough monies in the budget to currently move this forward (in the region of £2,256). (Defib & cabinet cost would be £1,225) Will keep on radar for the future. Cllr Buxton stated that he had already written to the Haywain regarding installing one on the outside of the pub, but had yet to receive a response. Will chase with landlord.
