Clerk stated that the light was reinstated after a member of the public contacted TDC, requesting lighting for children getting off the school bus.

Cllr Smith stated that it does in fact also light up the post box and the bus time-table. Cllr Smith proposed that Clerk contact TDC to request the light be placed on a timer or reposition the angle of the light. 2nd Cllr Barrett – Unanimously agreed.
