He obtained monies from "People coming home from war fund", (most had already passed away) so monies started the Amenities group, which served people within the village. Ie Fates / Children parties etc. He was also responsible for the instigation of the village sign. His visions was to bring the village closer together.

Funeral will be held at Weely Crematorium on 27th September 23 @ 11am. Cllr Buxton proposed that we think about some sort of tribute from the village to commemorate his contributions over the years.

77/12. Great Grid Upgrade - Pylons and Proposed Substation

National Grid is currently reviewing the feedback, and they will go to consultation again next year.

77/13. Five Estuaries Windfarm - Underground Cables and Proposed Substation

Have delayed the application until spring next year. They have signed a good neighbour agreement between themselves and North Falls and are intending to work together to minimize disruption. Sub Station size reaching 6 hectares, Cables down to 2 for each trench and they have indicated that they will come to LBPC at the end of the year, to demonstrate what they are proposing for minimum disruption. Current proposal is to leave the trenching open for the entire project (2 years) until they are ready to backfill. Member of the public stated that this would be devastation for the wildlife.
