74/9. Planning 23/00439/OUT

Outline Planning Application (all matters reserved) for proposed erection of two dwellings.

Land West of Hunyani Ardleigh Road Little Bromley Essex CO11 2Q

Applied to demolish current garage and erect 2 bungalows on the space provided and in the outlined planning area. Plot of land was not previously within the boundary until about a year ago. LBPC unanimously opposed the boundary line being moved, but Tendring granted permission. Currently 4 objections on the Planning website. Highways stated that they require removal of the boundary hedge which would be all the way down until Shop Road, which would devastate that side of the roadway. There are also several mature trees that would have to be removed to accommodate the buildings, and the plan also goes over the actual outline planning boundary. Another concern is that if the garage is demolished it would decrease the land attached to Hunyani, and there would be cars parked along Ardleigh Road, as they would be using the one existing driveway. Proposed that the Council express concerns to the Application, 2nd Cllr Smith. Cllr Buxton to write a letter of concern to TDC, and make comment on Planning site.

21/01523/FUL

Mr Neil Napthine - BrandArt Ltd

Land adjacent Cliphedge Farm, Harwich Road Little Bentley

Proposed construction of buildings to serve a class E use (including offices; financial, professional, and medical Services). Plus ancillary site works (car parking, landscaping, new vehicular access points off Harwich Road and stopping up to existing access).

Currently going through the planning appeal. Great Bromley and Little Bentley have already opposed the development. Planning inspector is now involved and there is a meeting to be held on the 13th June @ Clacton Town Hall. Cllr Buxton proposed that this is now left to Little Bentley Parish Council. 2nd Cllr Smith – Unanimously agreed. Cllr Fairley Stated that the first application was originally approved by TDC, but planning committee refused. There is also another application in the system 22/02019/FUL similar scheme, but slightly reduced, therefore depending what happens with original application this may be withdrawn.

Cllr Buxton stated that there is another planning application, but due to it being farming property, LBPC has no say in the matter, as conversion to agriculture use. Application has been made to convert the 3 Barns at the bottom on Brahams Hall Lane into 4 houses. This is the 3rd Application, previous two applications have been turned down.

74/17. East Anglian Green Project - Pylons and Proposed Substation

Essex /Suffolk/ Norfolk Pylons pressure group headed by Rosie Pierce — fighting hard to have the pylon development removed from discussion and to go completely of shore. Currently with MP's including Bernard Jenkin. Recently been on National TV - ITV Local news talking with the Energy Minister - Andrew Bowen. Cllr Buxton stated that it is still important for Residents to send letter of objection with valid reasons to Mr Jenkin, to keep pressure on. Project has been delayed by 1 year due to current pressure.

If this project can be stopped then Five Estuaries and North Falls would probably not go ahead.

74/18. Five Estuaries Windfarm - Underground Cables and Proposed Substation

Currently obliged to continue to meet deadlines set.

Cllr Buxton would like to thank everyone who wrote letter of objection and cc LBPC in via email Cllr Fairley stated that Companies are obliged to publish peoples concerns.

74/19. North Falls Windfarm - Underground Cables and Proposed Substation

Are now out to consultation giving 3 options

- Make land fall and drive their own cable routes through to their substation.
- Make land fall and share cable routs with Five Estuaries to their substation
- > To go offshore

Concluding 14th July 2023.

The substation position would be to the west of the Village 300 metres x 200 metres. They have also stated they would like to integrate their substation into Nationals grid, which is the opposite side of village. The route would be up Bentley road and across a hall road back of Paynes Lane. Lorries being run every 10 to 15 minutes daily during construction. Would like to hold another Extra Ordinary meeting to discuss this project – Suggested date Thursday 29th June - TBC Cllr Fairley stated that Bernard Jenkin has said that he is willing to organize a public meeting for residents around the area, including Ardleigh Parish Council.
