#### 70/15. East Anglian Green Project

National Grid (NG) has now published its "Environmental Impact Assessment (EIA) Scoping Report" on the Planning Inspectorate website. This will allow NG to agree with the Planning Inspector what is in scope / out of scope for the project, part of the process to allow the Development Consent Order application to be submitted. NG seem to have ignored any of the negative feedback already submitted and are making the presumption that the project will go ahead. The Essex/Suffolk/Norfolk Pylons group has written a response to the report, validated by a KC, asking why this project is even being considered. LBPC concern is not just the pylons that would be erected, but also the very large substation next to the village (currently planned for the far side of Grange Road) which will be approximately 23/25 hectares and house equipment up to 24 metres in height. Also, NG has given 'permission' for Five Estuaries & North Falls Offshore Windfarms to position their substations around the same location (currently planned for the Little Bromley side of Grange Road). Each of these substations will be around 8 hectares in size and house equipment up to 18 metres in height. The 3 sub stations between them take up approximately 100 acres of land. In the EIA NG are proposing to make many items out of scope for evaluation, such as impact on the surrounding land,

economic effect, impact on land drainage, noise, impact on well water, vibration, impact on irrigation bore holes and more. NG has also asked for its project to be considered in isolation without taking into account the cumulative impact of Five Estuaries and North Falls developments.

Cllr Buxton proposed that LBPC respond to the Planning inspectorate (by 5th December) outlining our concerns for the 3 projects and the impact they will have on the village. 2<sup>nd</sup> Cllr Sauka – Unanimously agreed.

## 70/16. Five Estuaries Windfarm & proposed Substation

Have published their response to the public point of views, and are planning to submit to Planning Inspectorate in the New Year.

### 70/17. North Falls

Cllr Buxton attended their exhibition and will submit a letter of response along the same lines as letter sent to Five Estuaries and National Grid (as approved by LBPC).

The current plan is to run underground trenching through the South side of the village starting from Horsley Cross area to the new planned substation around Grange Road. The cable access width will be between 60 metres and 120 metres wide depending on trenching method used. The new substation will be around 8 Hectares in size and house equipment up to 18 meters high.

## 70/18. Memorial Garden
