Asked for more people to join the campaign, Explained that they are a group of people, that are gathering information regarding the above projects, and getting the information out to local residents. Keeping people updated via the Facebook page, but will also email out the information to those that have registered their email addresses. Website is also kept updated.

Cllr Fairley (District Councillor) reported.

Five Estuaries – The examination closed 2 weeks ago. The Examining Authority now has three months to finalise its report and recommendation to the Secretary of State. The Secretary of State will then have a further three months to review the report and make a final decision on the Development Consent Order (DCO). This means we can expect a decision by the end of September.

North Falls – Reached Deadline 3 (of 8), and hearings are scheduled to begin on 1 April, lasting four days, including an accompanied site visit. TDC and ECC representatives will be present throughout the hearings. There will be further issue specific hearings scheduled in the coming months as well.

- TDC remains very concerned about the cumulative effects of both Five Estuaries and North Falls and believes that these impacts cannot be fully assessed, particularly as each DCO application is examined by a different authority.
- Clearly there are two DCOs (National Grid's Norwich to Tilbury and Tarchon Energy) yet to be submitted. Both targeting the same area for a connection to National Grid's EACN at Little Bromley/Ardleigh area. TDC has consistently raised this concern in its correspondence relating to both projects.
- **Norwich to Tilbury** – A targeted consultation on minor changes affecting the Tendring area is currently underway, with TDC's response due at the end of next week. This local consultation closes on 27 March. As part of their response,
 - TDC remains unconvinced that alternative sites for the East Anglia Connection Node (EACN) have been adequately considered. In particular, they believe National Grid's latest information lacks sufficient planning justification for its preferred location compared to alternatives such as the former RAF Boxted site.
 - They are not saying Boxted should be the site chosen, just that the planning argument/justification for siting the EACN at Ardleigh/Little Bromley has not been made. Information relating to how the other sites have been ruled out, while Ardleigh/Little Bromley has been preferred, has not been made available within their published documentation.
 - While TDC acknowledges the need for additional grid capacity, the Electric Systems Operator's (ESO, now NESO), East Anglia Network Study back in March 2024, identified multiple reinforcement options that could provide the same capacity, with potentially lower environmental impacts.
 - TDC believes that alternatives—such as an offshore-cantered approach or High Voltage Direct Current (the HVDC) undergrounding—should still be fully explored.
 - This is because a clear costs vs benefits illustration between the various options has not been produced, especially when a longer term view is taken.
 - If a viable alternative can be delivered in a timely manner without compromising Net Zero, renewable generation, and decarbonization targets, it would be welcomed by TDC. It would also be welcome by our communities which TD represent.

- Additionally, TDC remains concerned about various other aspects of this project, which will be outlined in their targeted consultation response.
- **Tarchon Project** – Last week, the Tarchon project team held a series of non-statutory consultation drop-in sessions at four locations across the district.
 - The project is still in its early, non-statutory consultation stage, but initial plans indicate a landfall area south of Harwich.
 - Underground cables would transport power from the landfall zone to a proposed Tarchon converter station (exact location unknown – although their maps, available online on their website show a red hatched area where they have indicated it will be). High Voltage Direct Current (HVDC) from the landing point would be converted to High Voltage Alternating Current (HVAC).
 - The Tarchon converter station would also connect to the EACN via underground cabling which will involve similar construction impacts to the other projects once their cable route is finalised.
- TDC met with Ardleigh and Little Bromley Councils, and have been discussing their response to the NG local consultation.
