1. Apologies for absence

Councillor Steve Wilcox has sent a note to say he would not be attending.

In the absence of a Chairman for the meeting, Sarah Candy was proposed by Anita Spall and seconded by Ken Hatch to Chair this meeting. Sarah Candy then proceeded to explain why this extra ordinary meeting was being held.

2. Election of Vice Chairman

Following the resignation of Bob Middleton, we need a new Vice Chairman. Sarah Candy indicated that she would be willing to take on this role, so was proposed by Anita Spall and seconded by Ken Hatch. Sarah Candy formally accepted the position as per the legislation.

Concerns were raised about the damage to the Jubilee Tree - which appears to have been run over by a vehicle and the 2 footpath signs (Chequers Road and near the Rectory) which have been sawn down. This should be reported to the Police.

the administration of the Parish Council. An advert will be placed in the Messenger.

9. Casual Vacancy update

It was explained that an election has been called. The names of the 10 people who called the election were read out and it was noted that 3 of the names were recent Parish Councillors.

It was explained that to have Poll Cards will cost the Village £327.43 It was formally resolved that we will not have poll cards for the forthcoming election The election is being called for 10th October and will be published on the 5th Sept Friday 6th - Friday 13th September is the date for nominations

11. Public Participation

It was stated that the May Minutes have not been put up on the website Action: Sarah Candy to put on the next Agenda

Concern was raised that if the meetings are recorded that the tapes are not kept for future use - it was agreed that tapes will be destroyed after the minutes are agreed

A member of the Public read out a statement regarding the Chairmanship of the Parish Council

"it is obvious to all that you have made the P.C. very unpopular through your style of Chairmanship, your inability to budget and the expectation that any amount in the funds is elastic. I would ask you to also stand down by resigning from this P.C."

This was voted on Six people voted in favour of the comment being forwarded to the Chairman and one voted against.

The Vice Chairman, in the Chair for the meeting, agreed to forward the comment to the Chairman.

The meeting closed at 8.40pm
