42/10. Planning Applications

Mully's Farm

Have been found to be in breach of previous planning application, since 2016. Have now submitted new application, to change usage of Farm Buildings.

Council met previously to discuss application. Unanimous decision was to make objection.

Resolved to move the planning application before the District Council Planning Committee.

Proposed Cllr Buxton, 2nd Cllr Spall, unanimously agreed Clerk already made objection on on-line Planning.

Grove Cottage

Planning application has been withdrawn. Clerk to make enquiries to find out what is happening as they are still in breach of planning.

42/11. Broadband -

Clerk stated that County Broadband had made contact regarding holding a meeting in the village. Cllr Spall stated that 24 homes had expressed an interest in County Broadband. Open Reach is currently fitting the fibre optic cabling to Shop Road enabling Little Bromley to access Superfast Broadband. The Superfast Essex Website will be updated at the end of April to give a timescale for completion of this work. Of the 93 addresses submitted to Open Reach, most will be getting FTTP (Fibre to the Premises).
