### Mully's Farm

#### 46/11. Broadband update

BT have now installed fibre into Shop Road. Residents are able to make internet connection through BT, but not yet through other providers. Unfortunately some villagers will still not be able to receive FTTP, but County Broadband are still open to subscription.
